



## Freeport LNG donates to the MLKCC, Inc.

LAKE JACKSON, JUNE 26: Freeport LNG Development L.P.<sup>™</sup> and the company's Chairman and Chief Executive officer (CEO), Michael Smith, have announced plans to contribute \$1,000,000 payable over the next five years to the Martin Luther King Jr. Celebration Committee of Brazoria County, Inc. This donation is the largest the organization has received to date, and it will be received in increments of \$200,000 per year starting in 2020.

*Freeport LNG is the second largest LNG export facility in the United States and the seventh largest in the world. The company's LNG terminal is located on Quintana Island near Freeport, Texas. Freeport LNG's terminal is the only all-electric motor driven facility of its kind, making it the most environmentally sustainable LNG terminal in North America. The facility's electric drive motors reduce carbon emissions by over 90%. Freeport's clean burning LNG is exported to foreign countries to reduce their dependence on dirty fuels. Freeport LNG plans to expand by adding a fourth liquefaction train, which has received all regulatory approvals for construction. Freeport LNG Development, L.P. was formed in 2002 and began LNG import operations in June 2008 and export operations in 2019. Freeport LNG's limited partnership interests are ultimately held by Michael S. Smith, Global Infrastructure Partners, and Osaka Gas Co., Ltd.*
